8 An ordinance amending the millage rates for the City of Slidell for fiscal
9 year 2001, number two (2).

10 BE IT ORDAINED by the Slidell City Council of the Parish of St.
11 Tammany, Louisiana, in a public hearing held on November 28, 2000, which hearing
12 was conducted in accordance with the open meetings law and the additional
13 requirements of Article VII, Section 23(C) of the Constitution, that the taxing authority
14 voted to increase the millage rate(s), on all taxable property shown on the official
15 assessment roll for the tax year 2000, and when collected, the revenues from said
16 taxes shall be used only for the specific purposes for which said taxes have been
17 levied. Said millage rate(s) are:




