6 **ORDINANCE NO. 2990**

8 An ordinance annexing and zoning 3.17 acres of land located on Pearl
9 Street directly south of Washington-St. Tammany Electric Cooperative, from C-2
10 Parish Highway Commercial to City C-4 Highway Commercial, as petitioned by Joseph
11 Taylor.

12 WHEREAS, the Slidell City Council has received a petition from Joseph
13 Taylor to annex and zone 3.17 acres of land from C-2 Parish Highway Commercial to
14 City C-4 Highway Commercial zoning designation; and

15 WHEREAS, said property is bounded by Gause Blvd. to the north, Rue
16 Holiday to the south, Pearl Street to the east, and Meadow Lake to the west; and

18 WHEREAS, the Slidell Planning and Zoning Commission has issued a
19 favorable recommendation for said annexation and zoning.

21 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that the
22 following described parcel of land be annexed into the corporate limits of the City of
23 Slidell into Councilmanic District E and zoned C-4 Highway Commercial, and more
24 fully described as follows:

27 ALL THAT CERTAIN LOT OR PARCEL OF GROUND in Section 7, T-9-
28 S, R-15-E, 8th Ward, St. Tammany Parish, Louisiana, being more fully
29 described as follows: From the corner common to Section 1 and 12, T-9-
30 S, R-14-E, which is the point of beginning, go south 00 degrees, 01
31 minute, 40 seconds West, 330.0 feet to a point and corner; thence go
32 south 89 degrees, 43 minutes east, 418.0 feet to a point and corner on
33 the west right-of-way line of Pearl Street; thence go north 00 degrees, 01
34 minute, 40 seconds East, along the west right-of-way line of Pearl Street,
35 330.0 feet to a point and corner; thence go north 89 degrees, 43 minutes
36 west, 418.0 feet to the point of beginning.




