6 **ORDINANCE NO. 2992**

8 An ordinance authorizing the Mayor of the City of Slidell to execute an
9 Acceptance of Donation from the Pravata family for property on Kaycee Drive that is
10 currently being used as a city park.

11 WHEREAS, the Pravata family has offered an Act of Donation for a
12 certain parcel of land located on Kaycee Drive currently being used as a city park; and

13
14 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it
15 does hereby authorize the Mayor to execute an Acceptance of Donation from the
16 Pravata family (Linda Pravata Bolian, Barbara Pravata Penton, Renell Pravata Dore
17 and Maris Pravata Leitz), for a certain parcel of land located on Kaycee Drive, on
18 behalf of the City of Slidell, and more fully described as follows:

22 ALL THAT CERTAIN LOT OR PARCEL OF GROUND, together with all
23 the buildings and improvements thereon, and all the rights, ways,
24 privileges, servitudes, appurtenances and advantages thereunto
25 belonging or in anywise appertaining, situated in St. Tammany Parish,
26 State of Louisiana, and more fully described as follows:

27 Commencing at the Southeast Corner of the Southwest Corner of the
28 Southwest Corner (SW1/4 of SW1/4) of Section 4, Township 9 South,
29 Range 14 East, go North along the east line of said SW1/4 of SW1/4 of
30 Section 4 a distance of 472.35 feet to the point of beginning; thence
31 continue north 47.65 feet along the east line of said SW1/4 of SW1/4 of
32 Section 4 to a corner, which is the Southwest corner of a parcel of land
33 acquired by the Slidell Little Theatre in an act of exchange with Peter D.
34 Pravata, dated 3 December 1970 and recorded at COB 593, folio 284;
35 thence go east 125 feet to the west line of Kasey Drive for a corner;
36 thence go south 47.65 feet along the west line of Kasey Drive for a corner;
37 thence go west 125 feet to the point of beginning.

38 This property lies between the Slidell Little Theatre tract described above
39 and the tract given to the Veterans Club of Slidell, Inc., by act dated 28
40 November 1967 and recorded at COB 483, folio 31.

41 Being a portion of the same property acquired by Peter D. Pravata as per
42 COB 234, folio 216 of the official records of St. Tammany Parish,
43 Louisiana.

44 BE IT FURTHER ORDAINED that the Slidell City Attorney shall review all
45 necessary documents to provide for the acceptance of said property.




