5 **ORDINANCE NO. 3000**

6  
7 An ordinance amending the Code of Ordinances of the City of Slidell,  
8 Chapter 23 Solid Waste, Section 23-5 Collection fee, and Section 23-6 Recycling  
9 collection fees, to provide for increased costs paid by the City attributed to Consumer  
10 Price Index adjustments.

11  
12 WHEREAS, the City of Slidell has a garbage collection contract with  
13 Waste Management; and

14  
15 WHEREAS, said contract has provisions for annual increases equivalent  
16 to the Consumer Price Index.

17  
18 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it  
19 does hereby amend its Code of Ordinances Chapter 23 Solid Waste, Section 23-5  
20 Collection fee, and Section 23-6 Recycling collection fees, as follows:

23 Section 23-5 Collection fee, Paragraph (a):

24  
25 In the first sentence of Paragraph (a), delete the language "\$6.27" and  
26 replace with "\$6.65".  
27

28 Delete Section 23-5, Paragraph (b) in its entirety and replace with:

29  
30 "(b) At the start of the fiscal year beginning July 1, 2002, and every  
31 fiscal year thereafter, the solid waste collection fee shall be adjusted by a  
32 percentage amount equal to the new percentage change in the CPI  
33 (Consumer Price Index, All Urban Consumers) or five percent (5%),  
34 whichever is less."

38 Section 23-6 Recycling collection fees, Paragraph (a):

39  
40 In the first sentence of Paragraph (a), delete the language "\$2.38"  
41 and replace with "\$2.52."  
42

43 Delete Section 23-6, Paragraph (b) in its entirety and replace with:

44  
45 "(b) At the start of the fiscal year beginning July 1, 2002, and every  
46 fiscal year thereafter, the recycling collection fee shall be adjusted by a  
47 percentage amount equal to the new percentage change in the CPI  
48 (Consumer Price Index, All Urban Consumers) or five percent (5%),  
49 whichever is less."


