5 **ORDINANCE NO. 3026**

7 An ordinance amending the Code of Ordinances of the City of Slidell, Sec.  
8 29-43, to provide for liability insurance policy limits for taxicabs.

9  
10 WHEREAS, on July 10, 2001, the Slidell City Council amended the Code  
11 of Ordinances of the City of Slidell, Section 29-43, Insurance prerequisite to license, to  
12 raise the liability insurance policy limits for taxicabs; and

13  
14 WHEREAS, the information furnished to the City upon which the said  
15 amendment was based was erroneous; and

16  
17 WHEREAS, the Slidell City Council desires to set appropriate liability  
18 insurance policy limits for taxicabs.

19  
20 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it  
21 does hereby amend the Code of Ordinances as follows:

22  
23 Delete Sec. 29-43 in its entirety and replace with the following:

24  
25 **"Sec. 29-43. Insurance prerequisite to license.**

26  
27 Before any person shall be issued a new or renewal occupational license to  
28 operate a taxicab business, he shall submit satisfactory proof that he has in force  
29 liability insurance issued by an insurance company authorized to do business in the  
30 state, which policy shall be satisfactory to the Department of Finance and shall be in the  
31 following amount or more:

34 (1) For the death or injury of any one person, \$25,000.00.

5 one accident, \$50,000.00.




