7 **ORDINANCE NO. 3031**

8 An ordinance redistricting the Councilmanic districts for the City of Slidell.

9 WHEREAS, the 2000 census indicated population shifts for the City of  
10 Slidell; and  
11  
12

13 WHEREAS, in accordance with federal, state, and local regulations, the  
14 City of Slidell must redistrict its Councilmanic districts to coincide with changes in  
15 population; and  
16  
17

18 WHEREAS, district boundaries are proposed on physical features as  
19 defined by census block boundaries with efforts to keep districts contiguous and of  
20 similar size; and  
21  
22

23 WHEREAS, the Slidell City Council was cognizant of protecting the  
24 minority representation; and  
25

26 WHEREAS, the City of Slidell has a unique population composition  
27 wherein only 14:03 percent of its population is black; and  
28  
29

30 WHEREAS, the preservation of continuity of existing subdivisions and  
31 minority representation were among the criteria considered in this redistricting proposal.  
32

33 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it  
34 does hereby reapportion the City of Slidell's Councilmanic districts on physical features




