## **ORDINANCE NO. 3033**

An ordinance annexing and zoning 2.3485 acres of land located in Section 35, Township 8 South, Range 14 East, from Parish Institutional District to City C-2 Neighborhood Commercial, as petitioned by the Church of Latter-Day Saints.

WHEREAS, the Slidell City Council has received a petition from the Church of Latter-Day Saints to annex and zone 2.3485 acres of land located on Robert Boulevard; and

- 1. The use of the facility is limited to the following maximums:
  - a. Warehouse and receiving 7600 sq. feet;
  - b. Business Office 5,356 sq. feet;
  - c. Food Preparation Center 1,340 sq. feet;
  - d. Production/Preparation/Equipment room 3,929 sq. feet.
- 2. That no deliveries by truck are permitted before 9:00 a.m. and after 2:00 p.m.
- 3. That no more than two 18-wheeled trucks be on the site per month.
- 4. That all other codes drainage, landscaping, permits, traffic, etc. be adhered to before a permit is issued.
- 5. That this property be limited to Institutional Use.
