7 An ordinance amending the Code of Ordinances of the City of Slidell,
8 Appendix A Zoning, Part 2, by amending Section 515.08 of the Sign Ordinance to allow
9 for City sponsored signs/banners in the City right-of-way.

10 WHEREAS, the Slidell Planning and Zoning Commission has issued a
11 favorable recommendation with certain conditions.

12
13 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it
14 does hereby amend its Code of Ordinances, Appendix A Zoning, Part 2, by amending
15 Section 515.08.

18 515.08. Public signs and City-sponsored community promotional signs or
19 banners erected in the public right-of-way. Promotional signs or banners erected in the
20 public right-of-way shall be subject to the following conditions:

24 1. Advertising space shall be limited to no more than the bottom 25% of
25 the banner.
26
27 2. Banner placement shall be limited to C-3 and C-4 zones only.
28
29 3. Banners shall be removed and replaced a minimum of once a year or
30 when damaged.
31
32 4. There shall be a limit of only one (1) banner per utility pole, and
33 placed no less than 20 feet from the street level. All banners shall be
34 uniform in height.

- 5 5. No banner shall be placed on the new decorative street light poles in
6 Olde Towne.
7
- 8 6. Banners placed on Gause Boulevard and on Old Spanish Trail shall
9 be placed on utility poles located within the median only, if a median
10 exists.
11
- 12 7. Banners shall be grouped together with a standardized design theme.
13
- 14 8. Banners shall not block visibility of existing business signs.
15
- 16 9. Banner locations must be approved by the Planning Department prior
17 to installation.

19 This ordinance shall be effective until January 1, 2005.
