6 An ordinance confirming the establishment of the Slidell Human Relations
7 Committee.

9 WHEREAS, Mayor Salvatore A. "Sam" Caruso has established the Slidell
10 Human Relations Committee; and

11
12 WHEREAS, the Slidell City Council agrees with the purposes of the
13 Committee and desires that the perpetuity of the Committee be ensured by enactment
14 of an ordinance.

17 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that:

19 A new Article IV, Section 17-50 is hereby enacted to read as follows:

21 **"ARTICLE IV. SLIDELL HUMAN RELATIONS COMMITTEE**

22 **Sec. 17-50. Committee.**

24 (a) There shall be a Slidell Human Relations Committee;

26 (b) The Committee shall be comprised of nine (9) members, appointed as
27 follows:

29 (1) two (2) members appointed by the Mayor;

31 (2) two (2) members appointed by the Slidell City Council;

33 (3) three (3) members appointed by the Ministerial Alliance of Greater
34 St. Tammany;

36 (4) one (1) member appointed by the Slidell Rotary Clubs;

38 (5) one (1) member appointed by the Slidell Chamber of Commerce.

4 (c) The terms shall be for three years, except for the initial appointments,

6 which will be as follows:

8 (1) the Mayoral appointees—
9 — one shall serve an initial term of three years
10 — one shall serve an initial term of two years;

12 (2) the Slidell City Council appointees—
13 — one shall serve an initial term of three years
14 — one shall serve an initial term of two years;
15
16 (3) the Ministerial Alliance of Greater St. Tammany appointees—
17 — one shall serve an initial term of three years
18 — one shall serve an initial term of two years
19 — one shall serve an initial term of one year;

21 (4) the Slidell Rotary Clubs appointee shall serve an initial term of one
22 year;
23 (5) the Slidell Chamber of Commerce appointee shall serve an initial
24 term of one year.

30 (d) The terms of the present members will be in effect until February 28,
31 2003. New terms will begin March 1, 2003.

34 (e) (1) All members of the Human Relations Committee shall reside within
35 the city limits at the time of their appointment and shall continue to
36 reside within the city limits throughout their term of office.




