8 An ordinance declaring certain adjudicated property of the City of Slidell,
9 described as SLIP NO. 26 of the MARINA CHAMALE' CONDOMINIUMS, surplus and
10 setting the method of disposing same.

11 WHEREAS, the City of Slidell acquired the following described property at
12 a tax sale more than five years ago and was granted good, valid and merchantable title
13 by Ordinance No. 3059 and as provided by Louisiana Revised Statute 33:2891.1-
14 33:2891.5 formerly R.S. 33:2881.1-33:2881.4:

17 ALL THAT CERTAIN LOT OR PARCEL OF GROUND, together with all
18 the buildings and improvements thereon, and all the rights, ways, means,
19 privileges, servitudes, appurtenances, advantages and component parts
20 thereunto belonging or in anywise appertaining, together with an
21 undivided 1/137% interest in and to the common elements and limited
22 common elements, lying and being situated in the MARINA CHAMALE'
23 CONDOMINIUMS, created under the Louisiana Condominium Act, R.S.
24 9:1121, 101, et seq., and being more fully described as SLIP NO. 26 of
25 the MARINA CHAMALE' CONDOMINIUMS, St. Tammany Parish,
26 Louisiana.

27 Said Condominium Slip is more fully described in the Condominium
28 Declaration creating and establishing the MARINA CHAMALE'
29 CONDOMINIUMS, and the plans and survey attached thereto, dated
30 October 22nd, 1981, and registered in COB 1035, folio 513 of the official
31 records of St. Tammany Parish;

32 WHEREAS, the City has no use for this property;

33 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that Slip
34 No. 26 of the Marina Chamale' Condominiums is no longer needed by the City of Slidell
