## **ORDINANCE NO. 3165**

An ordinance amending the Code of Ordinances of the City of Slidell, Chapter 10 Civic and Cultural Affairs and Facilities, by adding a new Section 10-34 requiring that any events sponsored or co-sponsored by the City of Slidell be approved jointly by the Mayor and the City Council.

WHEREAS, each year events are sponsored in some fashion by the City of Slidell; and

WHEREAS, there has been an increasing number of requests for City sponsorship of events which take place throughout the year; and

WHEREAS, these requests are being made to both elected and non-elected officials of the City; and

WHEREAS, City sponsorship of events should be a decision which is equally shared by both branches of City government.

NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it does hereby amend the Code of Ordinances of the City of Slidell, Chapter 10 Civic and Cultural Affairs and Facilities, by adding a new Section 10-34 as follows:

"Sec. 10-34. City sponsored events.

The City shall not sponsor any events without the approval of the Mayor and the City Council."
