8 An ordinance annexing and zoning 19.5 acres of land located South of Daney
9 Street, West of I-10 and North of Old Spanish Trail from Parish C-2 Highway Commercial
10 and Suburban Agriculture to City C-4 Highway Commercial zoning designation, as
11 petitioned by Emily and Jules Richard.

12 WHEREAS, the Slidell City Council has received a petition from Emily and
13 Jules Richard to annex and zone 19.5 acres of land located South of Daney Street, West
14 of I-10 and North of Old Spanish Trail from Parish C-2 Highway Commercial and Suburban
15 Agriculture to City C-4 Highway Commercial zoning designation; and

18 WHEREAS, said property is located West of I-10 and North of Old Spanish
19 Trail; and

21 WHEREAS, the Slidell Planning and Zoning Commission has issued a
22 favorable recommendation for said annexation and zoning.

24 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it does
25 hereby annex 19.5 acres of land located South of Daney Street, West of I-10 and North of
26 Old Spanish Trail into the corporate limits of the City of Slidell, into Councilmanic District A,
27 and zoned C-4 Highway Commercial and more fully described as follows:

32 A CERTAIN LOT OR PARCEL OF LAND, with all the buildings and
33 improvements thereon, lying and being situated in St. Tammany Parish, LA,
34 being more fully described as beginning at the northwest corner of the
35 northeast quarter of the northeast quarter of Section 14, T-9-S, R-14-E, St.
36 Hel Mer., going east five full chains to a post; thence south seventeen chains
37 to a post; thence north sixty-two degrees, west fifteen chains to a post;
38 thence north five chains to a post; thence east ten chains to the Point of
39 Beginning, containing nineteen acres, more or less, all according to a map or
plan of survey of J.J. Brakefield, Surveyor, dated February 23, 1916.
