8 An ordinance annexing a portion of Bridge Drive, Arbor Drive, Plum Drive and  
9 Desoto Street, as petitioned by the City of Slidell.

10 WHEREAS, the Slidell City Council has received a request from the  
11 Administration, to annex a portion of Bridge Drive, Arbor Drive, Plum Drive and Desoto  
12 Street; and

15 WHEREAS, said property is located in Highland Park Subdivision; and

17 WHEREAS, the Slidell Planning Commission has issued a favorable  
18 recommendation for said annexation.

20 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that the  
21 following described parcel of land be annexed into the corporate limits of the City of Slidell  
22 into Councilmanic District B, and more fully described as follows:

25 All that certain parcel of land known as Bridge Drive right-of-way that is 50  
26 feet wide from the south boundary line of Lopez Street right of way South to  
27 Northern Boundary of Windsor Place Subdivision.

29 All certain parcel of land known as Arbor Drive right-of-way that is 50 feet  
30 wide from the south boundary line of Lopez Street right of way South to  
31 Northern Boundary of Windsor Place Subdivision.



33 All that certain parcel of land known as Plum Drive right-of-way that is 50 feet  
34 wide from the south boundary line of Lopez Street right of way South to  
35 Northern Boundary of Windsor Place Subdivision.

37 All that certain parcel of land known as DeSoto Street right of way from the  
38 Western boundary of Highland Park Subdivision East to the Easternmost  
39 limits of Lot 1Sq 19 and Lot 10 Sq 20.




