7 **ORDINANCE NO. 3349**

8 An ordinance annexing Lots 4 & 5, Sq. 14, Robbert Park Subdivision, as  
9 requested by Trinity Construction of St. Tammany, Inc.

11 WHEREAS, the Slidell City Council has received a petition from Trinity  
12 Construction of St. Tammany, Inc, to annex and zone Lots 4 & 5, Sq. 14, located in  
13 Robbert Park Subdivision across Natchez from the parking lot of Lowes, from Parish A-5  
14 Two Family Residential District to City C-2 Neighborhood Commercial; and  
15

17 WHEREAS, the Slidell Planning and Zoning Commission has issued a  
18 favorable recommendation for said annexation.  
19

20 WHEREAS, Louisiana State Law prohibits rezoning to a more intense use for  
21 a period of two years unless the St. Tammany Parish Council consents to such rezoning.


23 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that Lots 4  
24 & 5, Sq. 14, Robbert Park Subdivision be annexed into the corporate limits of the City of  
25 Slidell into Councilmanic District E.

28 BE IT FURTHER ORDAINED that according to Louisiana Revised Statute  
29 33:172(A)(1)(e), since the property annexed pursuant to this ordinance is subject to St.  
30 Tammany Parish zoning regulations in force at the time of the effective date of this  
31 ordinance, then for a period of two years subsequent to the said effective date, the City of  
32 Slidell zoning regulations applicable to the property shall not be less restrictive in uses
