7 **ORDINANCE NO. 3392**

8 An ordinance relative to classified positions in the Water Treatment Plant.

10 WHEREAS, the Civil Service Board, at its meeting on December 13, 2006,  
11 voted unanimously to create and classify the following positions of Operator in Training as  
12 a Non Exempt Grade 4; Treatment Plant Operator I as a Non Exempt Grade 5; Treatment  
13 Plant Operator II as a Non Exempt Grade 7; Treatment Plant Operator III as a Non Exempt  
14 Grade 8; Chemist II as a Non Exempt Grade 12; and Chief Operator as a Non Exempt  
15 Grade 12; and

20 WHEREAS, the Civil Service Board also voted unanimously to reclassify the  
21 Sr. Treatment Plant Operator from Non Exempt Grade 9 to Non Exempt Grade 11; and

23 WHEREAS, sufficient funds are available to fill two of the newly created  
24 positions in the current fiscal year; and

25  
26 WHEREAS, funding for the reclassification of the Sr. Treatment Plant  
27 Operator position will be included for approval in the FY2008 Budget for the City of Slidell;

31 WHEREAS, funding for the creation of the Chemist II position will be included  
32 for approval in the FY2008 Budget for the City of Slidell.



35 are hereby created the following classified positions of Operator in Training as a Non  
36 Exempt Grade 4; Treatment Plant Operator I as a Non Exempt Grade 5; Treatment Plant


