10 WHEREAS, on November 27, 2007, the Council adopted Ordinance No. 3442
11 which revoked a portion of Strawberry Street; and

13 WHEREAS, the property description contained in Ordinance No. 3442 was
14 incorrect; and

16 WHEREAS, the City Council adopted Ordinance No. 3456 which contains a
17 property description that is sufficient but not precise; and

19 WHEREAS, the City has received a recent survey that shows the precise
20 property description.

22 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that
23 Ordinance No. 3456 is hereby rescinded.



26 contain the following property description:



29 "From the Southeast corner of Lot 1, Square 10, Northside Subdivision,
30 which is the point of beginning, go South 00 degrees 14 minutes 41 seconds
31 West 45 feet to a point on the South edge of Strawberry Street, thence go
32 West along the South edge of Strawberry Street 137 feet to a point, thence
33 go North 00 degrees 23 minutes 26 seconds West to the Southwest corner
34 of Lot 1, Square 10, Northside Subdivision on the North edge of Strawberry
35 Street, thence go East along the North edge of Strawberry Street 137 feet
36 back to the Southeast corner of Lot 1, Square 10, Northside Subdivision and
37 the point of beginning."
