6 An ordinance ratifying a previous Reallocation and Appropriation.

8 WHEREAS, on November 30, 2009, City Engineer Donna O'Dell notified
9 Chief of Staff Bob Dunbar that the bid opening for Municipal Center Building Two was held
10 on November 19, 2009; and
11

12 WHEREAS, Donna O'Dell further notified Bob Dunbar that the bids were
13 being analyzed and that a recommendation to the City Council as to the lowest responsive
14 bidder would be done on December 8, 2009; and
15

16 WHEREAS, on December 1, 2009, the City's Director of Finance, Sharon
17 Howes, requested a "Reallocation and Appropriation for Building #2 Construction". Sharon
18 Howes' justification for the Reallocation and Appropriation was "[t]o accept bids for building
19 #2 requires the appropriation and reallocation of funding sources. Bid at \$3,828,000.00
20 plus 5% contingency". Sharon Howes additionally advised that "[t]he above items will be
21 incorporated into the FY 2010 first supplemental budget"; and

23 WHEREAS, on December 8, 2009, the City Council approved the
24 Reallocation and Appropriation in the sum of \$4,019,000.00 which was the \$3,828,000.00
25 plus 5% contingency Sharon Howes requested. The Council further postponed the
26 acceptance of the bid for Building #2; and

9 Reallocation and Appropriation of December 8, 2009; and

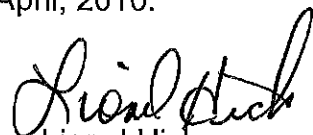
10 WHEREAS, the Council recognizes that this ratification operates as an

12 amendment to the FY2010 budget ordinance; and


13 WHEREAS, the Council desires to make the ratification retroactive to
