6 **ORDINANCE NO. 3613**

7 An ordinance amending Ordinance No. 3572, revising the Revenue, Expense  
8 and Capital Budget for fiscal year 2010-2011 (Second Supplemental Budget), providing for  
9 supplemental appropriations, additional revenues and matters in connection therewith.

10 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it does  
11 hereby amend Ordinance No. 3572, revising the Revenue, Expense and Capital Budget  
12 for fiscal year 2010-2011, as attached herewith and made a part hereof.  
13

14 BE IT FURTHER ORDAINED that the Slidell City Council does hereby  
15 establish personnel staffing and position classification levels for each department as  
16 presented in the Mayor's proposed budget booklet for fiscal year 2011, dated March 31,  
17 2010, and adopted May 25, 2010, and that the number of employees in each MSPG level  
18 shall be as therein stated for each position.  
19

20 BE IT FURTHER ORDAINED that Council approval is required to amend,  
21 change, increase or reallocate any MSPG levels or staffing, except certain positions in the  
22 Police Department, Wastewater Treatment Plant Division and in the Building Safety  
23 Department, who shall have automatic promotions depending upon time in service and job  
24 performance in accordance with Civil Service rules and with the approval of the Civil  
25 Service Director.

27 BE IT FURTHER ORDAINED that each item listed in the attached Capital  
28 Outlay Schedules shall constitute a separate program, and substitutions thereto shall  
29 require Council approval.

13 add \$250,000.

15 Under "DISA Building Fund", Page 6, Line 275, transfer out – Public Works Fund,  
16 add \$250,000.  
17

18 Under "DSA Building Fund", Page 6, Line 279, Capital & Reserve – Schedule VIII,  
19 deduct \$250,000.

22 Replace Schedule IV and Schedule VIII.  
23

24 BE IT FURTHER ORDAINED that the Finance Director is authorized to make  
25 the necessary adjustments to operating transfers between funds.  
26

27 BE IT FINALLY ORDAINED that this ordinance shall become effective upon  
28 signature by the Mayor.
