7 An ordinance annexing and zoning a parcel of land identified as (Legal #1 –
8 11.9602 acres) and a parcel of land (Legal #2 – 0.639 acres), located adjacent to I-10
9 Service Road (Lindberg Drive) and McKinney Road, Section 11, Township 9 South, Range
10 14 East, City of Slidell, St. Tammany Parish from HC-2 (Highway Commercial) to C-4
11 (Highway Commercial), as petitioned by Chris Jean, Southeast Investments, LLC, through
12 PDGR.

13 WHEREAS, the Slidell City Council has received a petition from Chris Jean,
14 Southeast Investments, LLC, through PDGR to annex and zone a parcel of land identified
15 as (Legal #1 – 11.9602 acres) and a parcel of land (Legal #2 – 0.639 acres), located
16 adjacent to I-10 Service Road (Lindberg Drive) and McKinney Road, Section 11, Township
17 9 South, Range 14 East, City of Slidell, St. Tammany Parish from HC-2 (Highway
18 Commercial) to C-4 (Highway Commercial); and


26 WHEREAS, the Slidell Planning and Zoning Commission has issued a

10 seller or buyer, pursuant to their contract dated December 01, 2010.


