11 Density Urban - Lots 2A-1 through 2A-10, and C-4 Highway Commercial - Lot 1A-1, as
12 petitioned by Reese C. Owen, Jr.


13 WHEREAS, the Slidell City Council has received a petition from Reese C.
14 Owen, Jr., to rezone a 3.25 acre parcel and a 3.16 acre parcel, recently resubdivided and
15 identified as Parcel 1A-1 (4.22 acres) and Parcels 2A-1 through 2A-10 (2.19 acres) from A-
16 9 Apartment Commercial and C-4 Highway Commercial to A-8 High Density Urban and C-
17 4 Highway Commercial; and


