7 An ordinance amending the Code of Ordinances of the City of Slidell,  
8 Chapter 27 Traffic and Vehicles to add Tammany Mall to the current parking lot ordinance.  
9

10 WHEREAS, Louisiana Revised Statute 32:41(D) provides that upon request  
11 of either the owner or the person in charge of the general operation and control of a  
12 parking area, local municipal authorities may adopt local ordinances to provide relative to  
13 the operation of a parking area; and

16 WHEREAS, the City has received such a request from Tammany Mall,  
17 L.L.C., owner of Tammany Mall located on Pontchartrain Drive; and  
18

20 Whereas the Chief of Police has no objection to adding Tammany Mall to the  
21 current parking lot ordinance; and

23 WHEREAS, the first paragraph of Ordinance 27-2(b) requires language  
24 updates;  
25

26 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it  
27 hereby amends the Code of Ordinances of the City of Slidell, Chapter 27 Traffic and  
28 Vehicles, Sec. 27-2 Police may regulate traffic, Paragraph (b) by deleting Paragraph (b)  
29 and replacing it with the following:

34 "(b) By the authority conferred by R.S. 32:41(D), in response to requests by  
35 Homart Development Co., the Slidell Housing Authority, Sam's Club # 6220  
36 on Northshore Boulevard, Walmart #2665 on Northshore Boulevard, and  
37 Tammany Mall, L.L.C. the Slidell Police Department is authorized to perform  
38 any and all activities specified in R.S. 32:41 (D) in the parking areas of the

4 properties known as North Shore Square, the Slidell Housing Authority,  
5 Sam's Club #6220 on Northshore Boulevard, Walmart #2665 on Northshore  
6 Boulevard, and Tammany Mall, L.L.C. on Pontchartrain Drive. In exercising  
7 this authority the Slidell Police Department, subject to the provisions of  
8 Ordinance Section 27-28."  
9

10 BE IT FURTHER ORDAINED that this Ordinance shall become effective upon  
11 adoption.
