8 An ordinance amending the Access and Parking Servitude Agreement
9 entered into by and between City of Slidell and Slidell Development Company, L.L.C.

10 WHEREAS, City of Slidell ("City") and Slidell Development Company, L.L.C.
11 ("SDC") entered into an Access and Parking Servitude Agreement ("Agreement") on May
12 2, 2014 and recorded in the Conveyance records of the Clerk of Court's Office, St.
13 Tammany Parish, Instrument No. 1940636; and

16 WHEREAS, City and SDC now desire to amend that Agreement to expand
17 the Servitude Parcel and grant additional servitude rights, obligations and limitations in
18 favor of Parcel 1 across and over the expanded Servitude Parcel, as defined in the
19 Amendment to Access and Parking Servitude Agreement ("Amendment") attached hereto
20 and made part hereof; and

23 WHEREAS, Slidell City Council does hereby authorize the Mayor to execute
24 the Amendment to Access and Parking Servitude Agreement.

27 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it does
28 hereby authorize the Mayor to execute the Amendment to Access and Parking Servitude
29 Agreement, attached hereto and made a part hereof, which expands the Servitude Parcel
30 and grants additional servitude rights, obligations and limitations in favor of Parcel 1 across
31 and over the expanded Servitude Parcel; and further sets forth that all terms, provisions
32 and conditions set out in the Agreement not modified or amended in this Amendment to
