8 An ordinance amending the Code of Ordinances of the City of Slidell, Chapter
9 2, Article III, Division 4, Section 2-157 (Mayor Compensation).

10 WHEREAS, the City of Slidell's Home Rule Charter, Article III, Section 3-06,
11 provides that the Mayor's salary shall be established annually by ordinance through the
12 budget process and that no ordinance changing the Mayor's salary shall increase such
13 salary by more than the average percentage of increase granted annually to all city
14 employees; and

19 WHEREAS, the average percentage of increase in salary granted to all City
20 employees, as proposed in the City's budget for the 2024-2025 fiscal year, is at least three
21 and one half (3.5%) percent (inclusive of a proposed uniform two (2%) percent cost-of-
22 living adjustment for all employees); and



26 WHEREAS, subject to the adoption of the 2024-2025 fiscal year budget
27 reflecting an average percentage of increase in salary granted to all City employees of at
28 least three and one half (3.5%) percent (inclusive of a proposed uniform two (2%) percent
29 cost-of-living adjustment for all employees), the Mayor will receive a salary increase
30 consisting of a two (2%) percent cost-of-living adjustment followed by a one and one half
31 (1.5%) percent raise.
