6 **ORDINANCE NO. 4171**

8 An ordinance amending the Code of Ordinances of the City of Slidell, Chapter  
9 2, Article III, Division 4, Section 2-157 (Council Member Compensation).

10  
11 WHEREAS, the City of Slidell's Home Rule Charter, Article II, Section 2-04.A,  
12 provides that Council Members' salaries shall be established annually by ordinance  
13 through the budget process and that no ordinance changing the Council Members' salaries  
14 shall increase such salaries by more than the average percentage of increase granted  
15 annually to all city employees; and

20 WHEREAS, the average percentage of increase in salary granted to all City  
21 employees, as proposed in the City's budget for the 2024-2025 fiscal year, is at least three  
22 and one half (3.5%) percent (inclusive of a proposed uniform two (2%) percent cost-of-  
23 living adjustment for all employees); and

27 WHEREAS, subject to the adoption of the 2024-2025 fiscal year budget  
28 reflecting an average percentage of increase in salary granted to all City employees of at  
29 least three and one half (3.5%) percent (inclusive of a proposed uniform two (2%) percent  
30 cost-of-living adjustment for all employees), each Council Member will receive a salary  
31 increase consisting of a two (2%) percent cost-of-living adjustment followed by a one and  
32 one half (1.5%) percent raise.

4           NOW THEREFORE BE IT ORDAINED by the Slidell City Council that, upon  
5  
6 adoption of the City's budget ordinance for the 2024-2025 fiscal year, and effective for the

8 first full pay period for the fiscal year beginning July 1, 2024, the salary of each Council  
9  
10 Member shall be set at \$25,702.00, and that the Code of Ordinances of the City of Slidell,  
11 Chapter 2, Article III, Division 4, Section 2-157 be amended to reflect such change.
