5 **ORDINANCE NO. 4300**

7 An ordinance for the City of Slidell (the "City") setting forth and designating the
8 City's millage rates, as required by Part II of Article VII of the Constitution of Louisiana and
9 other applicable law, for the purposes of maintenance and operation of garbage collection
10 and disposal, and sewerage works and facilities, in the City for the fiscal year 2026-2027.

11 SECTION 1. BE IT ORDAINED by the Slidell City Council of the City of Slidell,
12 Louisiana, in legal session convened, that there is hereby levied an aggregate tax of 8.82
13 mills on the dollar upon all property taxable, under the laws of the State of Louisiana,
14 situated in said City, according to the assessment roll of said City, in the calendar year
15 2026, for the purposes set forth below.

16 SECTION 2. BE IT FURTHER ORDAINED that said aggregate tax is
17 composed of the following authorized tax levies:
18

19 A tax of 4.45 mills for the purpose of maintaining and operating sewerage
20 works and facilities within the City of Slidell, Louisiana, for fiscal year 2026-2027, as
21 authorized by the special taxpayer election held in the City of Slidell, Louisiana on June
22 27, 2026.

23 A tax of 4.37 mills for the purpose of constructing and maintaining garbage
24 disposal works and refuse and garbage collection and disposal systems within the City of
25 Slidell, Louisiana, for fiscal year 2026-2027, as authorized by the special taxpayer election
26 held in the City of Slidell, Louisiana on June 27, 2026.

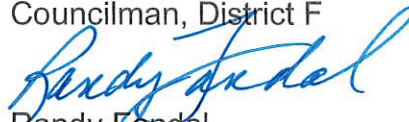
4 SECTION 3. BE IT FINALLY ORDAINED that the taxes herein levied are in
