

The following resolution was offered by Van Sandt and seconded by Barthelemy.

A resolution accepting and approving the amended certified statement or report of Cartier and Associates, Inc., consulting engineers, showing in detail the total cost of the construction of sewerage improvements within the corporate limits of Sewerage District No. 1-A of the City of Slidell, Louisiana, including the engineer's and attorney's fees and all other costs incidental thereto, together with the amount thereof chargeable to each lot or parcel of real estate abutting such improvements.

BE IT RESOLVED by the City Council of the City of Slidell, Louisiana, acting as the governing authority of Sewerage District No. 1-A of the City of Slidell, Louisiana:

SECTION 1. The amended certified statement or report of Cartier and Associates Inc., Consulting Engineers, dated July 8, 1985 and showing in detail the total cost of the construction of sewerage improvements within the corporate limits of the District, as set out in a resolution adopted by the City Council on November 22, 1983, ordering such improvements, and said report also showing the amounts thereof chargeable to each lot or parcel of real estate to be served or benefited in proportion that its frontage bears to all of the abutting lots or parcels of real estate to be served or benefited, the list of owners being attached hereto and the City Council having determined that each parcel of land to be assessed will be benefited to an amount not less than the proposed local or special assessment, be and the same is hereby accepted, after having been examined and approved by this City Council, said report being as follows:

Gentlemen:

On January 19, 1984 you received bids for the construction of sewerage improvements in Sewerage District No. 1-A. Thomas H. Heard General Contractor, Inc., with a bid of \$1,496,493.70, was determined to be the low responsible bid received. The project has since been revised, resulting in a reduction of cost to \$1,378,933.20.

SECTION 2. In accordance with aforesaid report which is hereby accepted and approved, and the contract awarded for the construction of sewerage improvements, and in compliance with the provisions of Article VI, Section 36 of the Constitution of the State of Louisiana for the year 1974, and Sections 33:3981 to 33:3996, inclusive, of Title 33 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority supplemental thereto, each assessable lot or parcel of real estate in said portion of the District described in the resolution adopted November 22, 1983, shall be assessed a local or special assessment chargeable to each lot or parcel of real estate in proportion that its frontage bears to all of the abutting lots or parcels of real estate to be served and benefited, covering the cost of the construction of said improvements.
