A Resolution OBLIGATING FUNDS TO LAND AND WATER CONSERVATION  
FUND PROJECT Region 1, Parish of St. Tammany, Project No. \_\_\_\_\_.

WHEREAS, the City of Slidell is interested in acquiring lands  
and/or developing outdoor recreational facilities on the following  
described project for the enjoyment of the citizenry of said city  
and the State of Louisiana:

PROJECT TITLE AND DESCRIPTION: Ducksworth Park

Softball field to include site preparation (rough grade,  
clear, fill, seed, sod), layout, backstop dugouts,  
sidewalks bleachers and project sign.

NOW, THEREFORE, BE IT RESOLVED by the Slidell City Council of  
St. Tammany Parish, State of Louisiana, that said city does agree to  
obligate the funds or services stipulated below to satisfactorily  
complete the following project and thus become eligible for Land and  
Water Conservation Fund financial aid of 50% of the estimated or actual  
allowable cost, at the completion of said project.


BE IT RESOLVED that such project and funds or services shall
