21 held in the City of Slidell, State of Louisiana (the "City"), to
22 authorize the levy of an additional one per cent (1%) sales and
23 use tax in the City, making application to the State Bond Com-
24 mission in connection therewith and providing for other matters
25 in connection therewith.

28 BE IT RESOLVED by the Slidell City Council, acting as
29 the governing authority of the City of Slidell, State of Louisiana,
30 that:

33 SECTION 1. Subject to the approval of the State Bond
34 Commission and under the authority conferred by Article VI, Section
35 29 of the Constitution of the State of Louisiana of 1974, the
36 applicable provisions of Chapter 5, Chapter 6A and Chapter 6B,
37 Title 18, Sub-Part D, Part I, Chapter 6, Title 33, Sub-Part F,
38 Part III, Chapter 4, Title 39 of the Louisiana Revised Statutes
39 of 1950, as amended, and other constitutional and statutory
40 authority supplemental thereto, an election be and the same is
41 hereby called and ordered to be held in the City of Slidell,
42 State of Louisiana (the "City"), on Saturday, September 27, 1986,
43 between the hours of six (6:00) o'clock a.m., and eight (8:00)
44 o'clock p.m., in compliance with the provisions of Section 541
45 of Title 18 of the Louisiana Revised Statutes of 1950 (R.S.
46 18:541), and that at the said election there shall be submitted
47 to all registered voters qualified and entitled to vote at the
48 said election under the Constitution and Laws of this State and

CITY OF SLIDELL ONE PER CENT (1%) SALES AND USE TAX
FOR PUBLIC SAFETY, PUBLIC WORKS AND CAPITAL IMPROVEMENTS
PROGRAM PROPOSITION

Shall the City of Slidell, State of Louisiana (the "City"), under the provisions of Article VI, Section 29, of the Constitution of the State of Louisiana of 1974, Sub-Part D, Part I, Chapter 6, Title 33 of Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority supplemental thereto, be authorized to levy and collect, and adopt an ordinance providing for such levy and collection, an additional tax of one per cent (1%) (the "Tax") upon the sale at retail, the use, the lease or rental, the consumption and storage for use or consumption, of tangible personal property and on sales of services in the City, all as defined in La. R.S. 47:301 through La. R.S. 47:317, with the proceeds of the Tax (after paying the reasonable and necessary expenses of collecting and administering the Tax) to be dedicated and used for purchasing, constructing, acquiring, extending, improving, maintaining and/or operating public facilities, public works or capital improvements and paying the capital costs of police protection and public safety for said City or any sites, equipment and furnishings therefore, as established and set forth in the City's then current budget adopted after public hearings held in the manner contemplated by the Home Rule Charter of said City, and further shall the City be further authorized to fund the proceeds of the Tax into bonds for the capital purposes set forth above for providing a reserve for said bonds and for paying the costs of issuance therefor, said bonds to mature over a term not exceeding twenty-five (25) years from date thereof, to bear interest at a rate or rates of interest not exceeding twelve per centum (12%) per annum and to be issued in accordance with the provisions of and subject to the limitations of Sub-Part F, Part III, Chapter 4, Title 39 of the Louisiana Revised Statutes of 1950 and other constitutional and statutory authority supplemental thereto, as the same now exist or may hereafter be amended?

SECTION 2. That there shall be published in "The Daily Sentry News", a daily newspaper of general circulation within the City, published in the City of Slidell, Louisiana, the official journal of this City, once a week for four consecutive weeks, with the first publication to be made not less than forty-five (45) days nor more than ninety (90) days prior to the date

14 be substantially in accordance with the Notice of Special Election

16 annexed hereto as "Exhibit A" and incorporated herein by reference

18 the same as if it were set forth herein in full.

20 SECTION 3. That this City Council, acting as the gov-

22 erning authority of the City, shall meet at their regular meeting
23
24 place, the Slidell City Council Chambers, City Hall, 2055 Second
25
26 Street, Slidell, Louisiana, on Tuesday, October 14, 1986, at

28 SIX-THIRTY (6:30) O'CLOCK P.M., and shall then and there in open
29
30 and public session proceed to examine and canvass the returns and
31
32 declare the result of the said special election.

34 SECTION 4. The polling place set forth in the aforesaid
35
36 Notice of Special Election and situated within the corporate
37
38 limits of the City be and the same is hereby designated as the
39
40 polling place at which to hold the said election, and the
41
42 Commissioner in Charge and Commissioners, respectively, will be
43
44 those designated in accordance with law.

46 SECTION 5. The officers designated to serve as Commis-
47
48 sioner in Charge and Commissioners pursuant to Section 4 hereof,
49
50 or such substitutes therefor as may be selected and designated
51
52 in compliance with Section 1287 of Title 18 of the Louisiana
53
54 Revised Statutes of 1950 (R.S. 18:1287), shall hold the said
55
56 election as herein provided, shall make due returns of said
57
58 election for the meeting of the Slidell City Council to be held
59
60 on October 14, 1986, and the compensation of said officers be and
61
62 the same is hereby fixed at the sum prescribed by law. All

64 registered voters in the City are entitled to vote at said

66 election and voting machines shall be used thereat.



16 as notification of the special election herein called in order
17 that each may prepare for said election and perform their
18 respective functions as required by law.

33 this resolution shall be forwarded to the State Bond Commission
34 on behalf of the Slidell City Council, together with a letter
35 requesting the prompt consideration and approval of this application.

51 services of said Bond Counsel in connection with the holding of
52 said election and levying of said tax to be performed without
53 compensation other than reimbursement for expenses in connection

55 accordance with the applicable schedule of the Attorney General
56 of the State of Louisiana, and subject to his approval.
