15 A resolution waiving the use fee for the Slidell City  
16 Auditorium to the St. Tammany Sheriff Deputies Association, Inc.

19 WHEREAS, the St. Tammany Sheriff Deputies Association, Inc.  
20  
21 is campaigning to renew a 1977 four and three-quarter mill tax  
22  
23 dedicated to the improvement of law enforcement within the St.  
24  
25 Tammany Parish Sheriff's Office by enabling them to improve sal-  
26  
27 aries and replace much needed equipment; and

29 WHEREAS, funds are needed to conduct such a campaign to  
30  
31 educate the people as to their needs; and

33 WHEREAS, the employees of the St. Tammany Parish Sheriff's  
34  
35 Office are planning a fund-raising talent show and dance to be held  
36  
37 on April 4, 1987 in an effort to offset some of the costs associated  
38  
39 with conducting such a campaign; and

41 WHEREAS, the St. Tammany Sheriff Deputies Association, Inc.  
42  
43 has humbly asked the City's help and support for their cause by  
44  
45 allowing them to hold their talent show and dance in the Slidell  
46  
47 City Auditorium, and at the same time waive the use fee for the  
48  
49 building; and

51 WHEREAS, this Council feels such assistance will help  
52  
53 a good cause.

55 NOW, THEREFORE, BE IT RESOLVED by the Slidell City Council  
56  
57 that fees for the use of the Slidell City Auditorium are hereby  
58  
59 waived for the St. Tammany Deputies Association, Inc. for April  
60  
61 4, 1987.

63 BE IT FURTHER RESOLVED that the St. Tammany Deputies  
64  
65 Association, Inc. shall pay to the City of Slidell a damage deposit  
66  
67 in the amount of one hundred seventy-five dollars (\$175.00) which  
68  
69 shall be refunded them by the City following the April 4, 1987 event  
70  
71 provided no damages occur to the Slidell City Auditorium as a result  
72  
73 of said event.
