15 A resolution approving the terms of a Services Agreement  
16 between the Parish of St. Tammany, Louisiana, Sales Tax  
17 District No. 3 of the Parish of St. Tammany, and the City  
18 of Slidell, Louisiana, in connection with the provision of  
19 services to the property of Slidell Motor Hotel, Inc., and  
20 authorizing and directing the Mayor of the City of Slidell  
21 to execute said Agreement.

23 **WHEREAS**, the City has received a petition to annex 43 acres  
24 owned by Slidell Motor Hotel, Inc.; and

26 **WHEREAS**, the Parish of St. Tammany, Sales Tax District No. 3  
27 of the Parish of St. Tammany and the City of Slidell, Louisiana,  
28 have agreed to share the costs of providing public services to the  
29 development;


34 **NOW, THEREFORE**, be it resolved by the City Council of the

38 **SECTION 1.** Pursuant to the provisions of the Inter-Governmental  
39 Agreement entered into between the Parish of St. Tammany, Sales Tax  
40 District No. 3 of the Parish of St. Tammany and the City of Slidell,  
41 the City Council of the City of Slidell, State of Louisiana, hereby  
42 approves the terms and conditions of a Services Agreement to be  
43 entered into by and between the Parish of St. Tammany, Louisiana;  
44 Sales Tax District No. 3 of the Parish of St. Tammany; and the City  
45 of Slidell, Louisiana, in connection with the provision of services  
46 to the property owned by Slidell Motor Hotel, Inc., said Agreement  
47 being substantially in the form attached hereto as Exhibit "A".
