16 A resolution authorizing retirement participation in
17 the Municipal Employee's Retirement System of the State of
18 Louisiana by the City Marshal and the Clerk of the Slidell
19 City Court of the City of Slidell, as provided by Act 1035
20 of the 1986 regular session of the Louisiana State Legislature.
21

22 WHEREAS, the Slidell City Marshal and Clerk of the City
23 Court of Slidell were being paid jointly by the City of Slidell
24 and Parish of St. Tammany, and should not have been enrolled in
25 the Municipal Employee's Retirement System; and

28 WHEREAS, the above mentioned City of Slidell employees
29 have been participating in the Municipal Employee's Retirement
30 System prior to Act 1035 of the 1986 Regular Legislative Session;

35 WHEREAS, in a recent opinion of the State of Louisiana,
36 the Attorney General required that we amend our agreement with
37 the Municipal Employee's Retirement System of the State of
38 Louisiana to include these employees, or they would loose their
39 retirement.

42 NOW THEREFORE BE IT RESOLVED by the Slidell City
43 Council, acting as the governing authority, do hereby authorize
44 the Slidell City Marshal and the Clerk of the City Court of
45 Slidell to participate in the Municipal Employee's Retirement
46 System of the State of Louisiana.

49 NOW BE IT FURTHER RESOLVED that a certified true copy of
50 this resolution be attached to the agreement between the City of
51 Slidell and the Municipal Employee's Retirement System.
