18 A resolution requesting that the Louisiana Department of
19 Transportation and Development to install a traffic control sign
20 on U.S. Highway 11, and also requesting the City of Slidell to
21 install traffic control devices within the Belvedere Subdivision
22 and the Albertson's development.

24 WHEREAS, the proposed Albertson's development is
25
26 scheduled for construction in the area of U.S. Highway 11 and
27
28 Lafayette Street; and

30 WHEREAS, traffic problems are anticipated in this
31
32 area; and
33

34 WHEREAS, additional traffic control devices and signs
35
36 will be required; and
37

38 WHEREAS, a traffic control island on the Albertson's
39
40 development is proposed that will prohibit through traffic on
41
42 Lafayette Street east or west bound crossing U.S. Highway 11.
43

44 NOW, THEREFORE BE IT RESOLVED that the Slidell City
45
46 Council does hereby request the Louisiana Department of
47
48 Transportation and Development to install a "No Left Turn" sign
49
50 south bound at the intersection of U.S. Highway 11 and Lafayette
51
52 Street.

54 NOW, THEREFORE BE IT FURTHER RESOLVED that the Slidell
55
56 City Council requests the following additional traffic control
57
58 measures:
59

- 60 1. Lafayette Street shall be one (1) way traffic
61
62 only going east from Front Street.
- 63 2. Place a "Do Not Enter" sign on Lafayette Street
64
65 at its intersection with Dale Street.
- 66 3. Provide a three (3) way "Stop" sign at the
67
68 intersection of 7th and Dale Streets.
- 69 4. Retain the "No Right Turn" sign at the

72 intersection of Lafayette and Dale Streets.
