## **RESOLUTION R88-45**

A resolution by Councilwoman Williams, Councilman-at-Large Martinez, Councilman-at-Large Singletary, Councilman Callahan, Councilman Salvaggio, Councilman Washington, Councilman Van Sandt, Councilman Barthelemy, and Councilman Berault, members of the Slidell City Council, to approve and authorize the Mayor of the City of Slidell to enterinto an Inter-Governmental Agreement with the Parish of St. Tammany, Sales Tax District No. 3, for distribution of sales tax proceeds; and to further authorize all members of the Slidell City Council to sign said resolution.

WHEREAS, various community and business leaders have urged the Parish and the Cities to find a peaceful solution to settle the problem without prolonged litigation; and

WHEREAS, the Police Jury has offered a proposal which would allow the Parish to issue bonds backed by the Parish's sales tax without negatively impacting future annexations into Cities of the Parish; and

WHEREAS, this Council believes that a prompt resolution of this dispute will serve the best interest of all citizens of the Parish.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Slidell, State of Louisiana that:

SECTION 1. Pursuant to the provisions of Article 6, Sec. 20, and Article 7, Sec. 14(c) of the Louisiana Constitution, LA. R.S. 33:1324, LA. R.S. 33:2721.6(g), LA. R.S. 33:2711(c), and other constitutional and statutory authority supplemental thereto, hereby approves the terms and conditions of an Inter-Governmental Agreement to be entered into by and between the Parish of St. Tammany, Louisiana, Sales Tax District No. 3 of the Parish of St. Tammany and the City of Slidell, Louisiana, in connection with the re-construction and maintenance of roads in St. Tammany Parish, Louisiana, said Agreement being substantially in the form attached hereto as Exhibit "A".

The Mayor of the City of Slidell, State of Louisiana, be and the same is hereby authorized to execute said Agreement for, on behalf of, in the name of and under the seal of the City of Slidell, State of Louisiana; and to further authorize all members of the Slidell City Council to sign said resolution.

SECTION 3. A copy of this resolution shall be immediately forwarded to the President of the Police Jury.
