12 **RESOLUTION R88-65**  
13

14 A resolution authorizing the allocation of an additional  
15 three hundred sixty-five thousand (\$365,000) dollars to the West Hall  
16 Roadway Project with said funds being appropriated from the  
17 Bond Interest Reserve Fund.  
18

19 WHEREAS, a low bid of one million two hundred thousand  
20 (\$1,200,000) dollars was received by the City for West Hall roadway  
21 improvements; and  
22  
23

24 WHEREAS, the low bid received by the City for the roadway  
25 improvements has exceeded the budgeted amount; and  
26  
27

28 WHEREAS, the City of Slidell had allocated eight hundred  
29 eighteen thousand (\$818,000) dollars for said roadway improvements;  
30  
31 and  
32  
33

34 WHEREAS, two hundred eighty thousand (\$280,000) dollars  
35 are needed for sewer repairs to comply with the State's Department of  
36 Environmental Quality compliance order along said roadway; and  
37  
38

39 WHEREAS, two hundred sixty-three thousand (\$263,000)  
40 dollars are required for engineering and project management fees; and  
41  
42

43 WHEREAS, it would be economically feasible to do all  
44 improvements simultaneously; and  
45  
46

47 WHEREAS, the City Administration, and the consulting  
48 engineers for the project recommend going forward with the project  
49 as bid; and  
50  
51

52 WHEREAS, a special bond interest reserve fund of five  
53 hundred twenty-six thousand (\$526,000) dollars was established as  
54 a separate line item in the 1988-89 fiscal year budget; and  
55  
56

57 WHEREAS, the specific intent of the bond interest  
58 reserve fund was to fund projects with insufficient budgets and/or  
59 funding.  
60  
61

62 NOW, THEREFORE BE IT RESOLVED that the Slidell City  
63 Council does hereby authorize the transfer of three hundred  
64 sixty-five thousand (\$365,000) dollars from the bond interest  
65 reserve fund into the West Hall Roadway Fund to provide complete  
66 funding for the project.

12 BE IT FURTHER RESOLVED that two hundred eighty thousand  
13 (\$280,000) dollars is hereby identified from the Inflow/Infiltration
