15 A resolution authorizing a transfer of thirty-four  
16 thousand (\$34,000) dollars from the Bond Interest Reserve Fund  
17 into the Rue Rochelle roadway repair fund.  
18

19 WHEREAS, the City of Slidell has roadway improvements  
20 currently in progress on Rue Rochelle; and  
21

22 WHEREAS, a budget of five hundred twenty-seven thousand  
23 (\$527,000) dollars has been established for said project; and  
24

25 WHEREAS, Phase A of said improvements had a cost of  
26 two hundred eighty-five thousand (\$285,000) dollars; and  
27

28 WHEREAS, the City Engineer has projected an additional  
29 cost of two hundred thirty-nine thousand (\$239,000) to complete  
30 Phase B of said improvements; and  
31

32 WHEREAS, Phase B would extend the improvements on Rue  
33 Rochelle from Rue Miramon to Gause Boulevard; and  
34

35 WHEREAS, a right hand turn land from Rue Rochelle onto  
36 Gause Boulevard is needed to improve traffic flow; and  
37

38 WHEREAS, said turn lane should be constructed in  
39 conjunction with Rue Rochelle improvements Phase B; and  
40

41 WHEREAS, said turn lane is estimated to cost eighty-one  
42 thousand five hundred (\$81,500) dollars by the City Engineering  
43 Department; and  
44

45 WHEREAS, the budget allocation is seventy-nine thousand  
46 (\$79,000) dollars below the needed funds to complete the above  
47 stated project.  
48

49 NOW, THEREFORE BE IT RESOLVED that the Slidell City  
50 Council does hereby allocate an additional seventy-nine thousand  
51 (\$79,000) dollars to the Rue Rochelle roadway improvement project  
52 with said appropriated to be funded from the Bond Interest Reserve  
53 Fund and any surplus funds from other completed capital projects  
54 identified by the Administration.
