15 A resolution rescinding and reenacting Resolution
16 R89-18 which provides funding for the purchase of right-of-way
17 for Airport Road.
18

19 NOW THEREFORE BE IT RESOLVED by the Slidell City
20 Council that Resolution R89-18 is hereby rescinded and reenacted
21 as follows:
22

23 A resolution providing funding for the purchase of
24 right-of-way for Airport Road.
25

26 WHEREAS, on September 16, 1986, by Ordinance No.
27 2012, the Slidell City Council approved an annexation agreement
28 with Northshore Limited Partnership; and
29

30 WHEREAS, this agreement provided funding for
31 right-of-way acquisition to widen Airport Road; and
32

33 WHEREAS, part of the right-of-way was to be
34 purchased from Airport Road Properties; and
35

36 WHEREAS, funding for the purchase was appropriated
37 in the \$3.8 million bond issue of 1986; and

39 WHEREAS, Airport Road Properties has not been paid
40 for the right-of-way; and


42 WHEREAS, all remaining funds from the \$3.8 million
43 bond issue have been re-budgeted for other projects; and
44

45 WHEREAS, there remains an unexpended balance from
46 prior year and current year appropriations for capital
47 equipment.
48

49 NOW THEREFORE BE IT RESOLVED by the Slidell City
50 Council that the City Administration is hereby authorized to
51 pay Airport Road Properties \$40,000 for the purchase of
52 right-of-way for Airport Road, the funding for which shall be
53 taken from the unexpended prior year and current year
54 appropriation for capital equipment. Said funding shall
55 consist of thirty-three thousand dollars (\$33,000) from
56 Utility Fund Equipment, and seven thousand dollars (\$7,000)
57 from Equipment (FY '89 allocation).
