13 A resolution authorizing the expenditure of two thousand
14 two hundred dollars (\$2,200.00) in conjunction with the second
15 annual National Pony Slow Pitch Championship Tournament for girls
16 sponsored by the Slidell Bantam Baseball Association.

18 WHEREAS, the Slidell Bantam Baseball Association (SBBA)
19
20 and the City of Slidell has been chosen to host the second
21
22 National Pony Slow Pitch Championship for girls; and

24 WHEREAS, said tournament will be held August 2, 1990;

28 WHEREAS, approximately seventy-two (72) teams from all
29
30 over the nation will visit the City of Slidell; and

32 WHEREAS, parents, directors, umpires, and friends of the
33
34 tournament association and participants will be in our City; and

36 WHEREAS, said visitation shall have a substantial
37
38 economic impact for merchants and hotel/motels; and

40 WHEREAS, the first annual tournament was estimated to
41
42 have brought in at least three hundred thirty-four thousand
43
44 dollars (\$334,000.00) into our economy; and

46 WHEREAS, the SBBA is funded under the authorization of
47
48 the organized Sports Assistance Act of the City of Slidell
49
50 Ordinance No. 1203, dated September 11, 1979.

52 NOW THEREFORE BE IT RESOLVED by the Slidell City Council

54 that the City of Slidell does hereby authorize an expenditure of
55
56 two thousand two hundred dollars (\$2,200.00) in favor of the
57
58 Slidell Bantam Baseball Association for assistance with the

60 National Pony Slow Pitch Championship Tournament to be held in the

62 City of Slidell beginning August 2, 1990. Said funds are to be

64 provided from the Legislative Operating Budget line item

66 10.1900.60099.

68 BE IT FURTHER RESOLVED that two thousand two hundred

70 dollars (\$2,200.00) is hereby transferred from line item
71
72 10.1900.60056 to line item 10.1900.60099 of the Legislative's
