16 WHEREAS, the fiscal year 89-90 budget has a contingency
17 of two hundred forty thousand dollars (\$240,000.00) for capital
18 improvements; and

22 WHEREAS, the City Council in conjunction with the Mayor
23 have agreed to expend these funds on roadway improvements; and

26 WHEREAS, the St. Tammany Parish Police Jury has
27 indicated a willingness to contribute thirty-two thousand three
28 hundred eighty-nine dollars and twenty-two cents (\$32,389.22)

30 towards improvements on Yaupon Drive.

34 NOW THEREFORE BE IT RESOLVED by the Slidell City Council
35 in joint agreement with Administration that two hundred forty
36 thousand dollars (\$240,000.00) identified as capital improvement
37 monies in the 1989-90 budget are hereby approved for expenditures

57 the prioritized list of street improvements submitted by City
58 Engineer, Stan Polivick, on May 11, 1990, shall be considered for
59 funding from the budget for 1990-91 as provided for by the five
60 hundred thousand dollars (\$500,000.00) street improvement program
61 therein contained.

66 BE IT FINALLY RESOLVED that it is the intention of this
67 Council to have compiled a prioritized listing of streets to be
68 improved by Councilmanic Districts, and to allocate approximately
69 one hundred thousand dollars (\$100,000.00) for street improvements
