WHEREAS, it is the desire of the City of Slidell that the funds be withdrawn, when available, and used in accordance with the herein described prioritization.

NOW THEREFORE BE IT RESOLVED by the Slidell City Council, the governing authority for the City of Slidell, that the withdrawal of funds on behalf of the City is approved contingent upon the use of funds for any public purposes as determined by a joint agreement between the city's Legislative and Executive branches of government.
