10 A resolution indicating the intention of the City of
11 Slidell, State of Louisiana, to become a participating political
12 subdivision in the Louisiana Local Government Environmental
13 Facilities Authority; and approving the appointment of a Director
14 to represent the City of Slidell, State of Louisiana, on the
15 Board of Directors of the Louisiana Local Government
16 Environmental Facilities Authority, as provided by chapter 10-D
17 of Title 33 of the Louisiana Revised Statutes of 1950.

19 WHEREAS, Chapter 10-D of Title 33 of the Louisiana Revised
20 Statutes of 1950, comprised of R.S. 33:4548.1 et seq., has been
21 enacted and is known as the Louisiana Local Government
22 Environmental Facilities Authority Act (the "Act"); and

25 WHEREAS, the Act has created a Louisiana Local Government
26 Environmental Facilities Authority (the "Authority") for the
27 purpose of assisting political subdivisions of this state in
28 constructing extending, rehabilitating, repairing, and renewing
29 environmental facilities (sewer, solid waste and drinking water
30 facilities), and assisting in the financing of such needs by
31 political subdivisions of this state; and

34 WHEREAS, the City of Slidell, State of Louisiana, is
35 eligible to become a member of the Authority in accordance with
36 the Act; and

39 WHEREAS, pursuant to Section 4548.4 of the Act, the
40 governing authority of the City of Slidell, State of Louisiana,
41 desires to become a member of the Authority and to approve the
42 appointment of the Director of Finance to serve as a Director of
43 the Authority.

46 NOW THEREFORE BE IT RESOLVED by the governing authority of
47 the City of Slidell, State of Louisiana, acting in such capacity:


50 Section 1. That, under the authority of Chapter 10-D of

53 Title 33 of the Louisiana Revised Statutes of 1950, it
54 is hereby declared to be the express intention of the
55 City of Slidell, State of Louisiana, to become a member
56 of the Authority, and thereupon becomes a participating
57 political subdivision of the Authority.

6 Section 2. That, pursuant to the Act, the appointment of

18 to the City of Slidell, State of Louisiana effective

20 immediately upon the adoption hereof.
