RESOLUTION R92-16

A resolution providing additional funds for Tyler Drive
Utilities Extension and Road Work.

WHEREAS, Resolution R91-55 was adopted by the Slidell
City Council on September 24, 1991, committing funds for sewer
and water line extensions as requested by the Slidell Motor Hotel
Incorporated; and

WHEREAS, said annexation also encompasses the Cracker
Barrel Restaurant, Inc; and

WHEREAS, the original resolution provided for one
hundred ten thousand dollars (\$110,000.00) of estimated utility
extensions; and

WHEREAS, Change Order No. 1 for the Tyler Drive
Utilities Extension project is recommended by the Engineering
Department; and

WHEREAS, said change order requires an additional
twenty thousand nine hundred forty dollars seventeen cents
(\$20,940.17); and

WHEREAS, part of said annexation proposal provided for
roadway improvements to Tyler Drive; and

WHEREAS, bids were received for Tyler Drive Paving
Project on February 28, 1992; and

WHEREAS, Bush Construction Alternate No. 2 in the
amount of thirty-eight thousand three hundred twenty-two dollars
eighty cents (\$38,322.80) is recommended by the Engineering
Department; and

WHEREAS, prior funding was provided from surplus funds
associated with Bond Issues Numbers 1 and 2 issued in 1987 and
1988 respectively; and

WHEREAS, funds were to be repaid from tax dollars
collected from the development at an interest rate of six percent
(6%) per annum until paid.
