10 A resolution naming and appointing Trustees of the St.
11 Tammany Public Trust Financing Authority and designating their
12 terms of office.

14 WHEREAS, the St. Tammany Public Trust Financing Authority
15 (the "Authority") was created pursuant to an Indenture dated March
16 6, 1979, by the governing authorities of the Cities of Covington
17 and Slidell; and

20 WHEREAS, the terms of Trustees of the Authority have
21 expired and there is a need to name and appoint successor Trustees;
22 and

25 WHEREAS, at the time of the creation of the Authority the
26 governing authorities of the Cities of Slidell and Covington
27 established a practice of appointing as trustees, the Mayor of
28 Slidell, the Slidell Councilman-at-Large receiving the greatest
29 number of votes at the last election, the Mayor of Covington, the
30 Chairman of the Covington City Council and on alternate years, the
31 Mayor of Mandeville and the Mayor of Pearl River; and

34 WHEREAS, the governing authorities of Slidell and
35 Mandeville subsequently changed their policy to provide that the
36 Mayors of Mandeville and Pearl River should alternate on two (2)
37 year terms; and

40 WHEREAS, the terms of the incumbent trustees expired on
41 March 6, 1991; and

44 NOW THEREFORE BE IT RESOLVED by the Slidell City Council,
45 acting governing authority of the City of Slidell, State of
46 Louisiana:

49 SECTION 1. That there are hereby appointed as trustees
50 for members of the St. Tammany Public Trust Financing Authority the
51 following persons for the terms indicated:

54 Salvatore A. Caruso, Mayor of the City of Slidell, for a term
55 expiring on March 6, 1997, or until he should cease to hold
56 his elected office of Mayor of the City of Slidell;

59 Alvin D. Singletary, Councilman-at-Large of the City of
60 Slidell, for a term expiring on March 6, 1997, or until he

5 shall cease to hold his elected office of Councilman-at-Large
6 of the City of Slidell;

8 Keith Villere, Mayor of the City of Covington, for a term
9 expiring on March 6, 1997, or until he should cease to hold

12 Donald Primes, Chairman of the Covington City Council, for a
13 term expiring on March 6, 1997, or until he shall cease to
14 hold the office of Chairman of the Covington City Council; and

15
16 James Lavigne, Mayor of the City of Pearl River, for a term
17 expiring on March 6, 1994, or until he should cease to hold
18 his elected office of Mayor of the City of Pearl River.

20 SECTION 2. That the above described appointments shall

22 become effective upon the concurrence of the City Council of the
23
24 City of Covington.
