9 A resolution endorsing the 1993 Leadership Slidell Committee project known  
10 as "First Impressions".  
11

12 WHEREAS, the Greater Slidell Chamber of Commerce has a Leadership  
13 Slidell Committee; and  
14

15 WHEREAS, said committee has adopted a project known as "First  
16 Impressions"; and  
17

18 WHEREAS, said project shall provide for certain landscaping at major  
19 entrance points into the City of Slidell; and  
20

21 WHEREAS, the project cost is approximately eighty-nine thousand, two  
22 hundred and fifty-five dollars (\$89,255.00); and  
23

24 WHEREAS, said Leadership Slidell Committee desires to receive funding  
25 from the Intermodle Surface Transportation Efficiency Act or I.S.T.E.A. program; and  
26

27 WHEREAS, this Leadership Committee has been in contact with the  
28 Louisiana D.O.T.D. and has had the project design completed by D.O.T.D. personnel; and  
29

30 WHEREAS, a three-year maintenance agreement between the Louisiana  
31 D.O.T.D. and the City of Slidell is necessary in order for this project to be funded by the  
32 Louisiana D.O.T.D.


34 NOW THEREFORE BE IT RESOLVED by the Slidell City Council that it  
35 does hereby express its intent to enter into an agreement with the State of Louisiana to  
36 maintain the landscaped portions of Interstate 12 and U.S. Highway 11, Interstate 10 and  
37 Gause Boulevard, and Interstate 10 and LA 433 (Old Spanish Trail) if the project is  
38 funded by the Louisiana D.O.T.D., through the I.S.T.E.A. Program.

40 BE IT FURTHER RESOLVED that the Slidell City Council hereby authorizes  
41 the Mayor to enter into a contract not to exceed twenty-one thousand dollars (\$21,000.00)  
42 per year for three (3) years, with the Louisiana D.O.T.D. for the maintenance of these  
43 interchanges.


