10 A resolution authorizing the City of Slidell to prepare and submit a pre-
11 application to the Statewide Flood Control Program for assistance for the implementation
12 of a project for the purpose of reduction of existing flood damages; providing for the
13 necessary documentation of said flood damages; and providing for other matters in
14 connection therewith.

15
16 WHEREAS, certain areas of the City of Slidell have been adversely affected
17 by damages from flood waters; and

18
19 WHEREAS, the City of Slidell desires to apply for state matching funds
20 pursuant to Chapter 2-A of Title 38 of the Louisiana Revised Statutes of 1950, as
21 amended, to implement a project to reduce said flood damages, and that the City of
22 Slidell is fully aware of its obligations under said Statute; and

23
24 WHEREAS, the City of Slidell is a political body duly organized and existing
25 under the laws of the State of Louisiana and is eligible to apply for funds under the
26 Statute.

27
28 NOW THEREFORE BE IT RESOLVED by the City Council of the City of
29 Slidell as follows:

30
31 Section 1. That the City of Slidell acknowledges that upon approval of the pre-
32 application a formal application will be prepared and submitted to the Statewide Flood
33 Control Program.



35 Section 2. That at the appropriate time and upon approval of funding assistance
36 and prior to commencement of work of project the City of Slidell agrees to execute a
37 Statement of Sponsorship pursuant to the Statute.

39 Section 3. That Stanley P. Polivick, P.E., City Engineer, is hereby designated
40 Authorized Representative for the City of Slidell to effect the preparation of the pre-
41 application and application to the Statewide Flood Control Program for funding assistance
42 of a flood control project.
