6 **RESOLUTION R94-29**

8 A resolution ordering and calling a special election to be held in the City of
9 Slidell, State of Louisiana, to authorize the levy of special taxes therein, making
10 application to the State Bond Commission in connection therewith and providing for other
11 matters in connection therewith.

12 BE IT RESOLVED by the Slidell City Council (the "Governing Authority"),
13 acting as the governing authority of the City of Slidell, State of Louisiana (the "City"), that:

14 **SECTION 1. Election Call.** Subject to the approval of the State Bond
15 Commission, and under the authority conferred by Article VI, Sections 30 and 32 of the
16 Constitution of the State of Louisiana of 1974, the applicable provisions of Chapter 5,
17 Chapter 6-A and Chapter 6-B of Title 18 of the Louisiana Revised Statutes of 1950, as
18 amended, and other constitutional and statutory authority, a special election is hereby
19 called and ordered to be held in the City on **TUESDAY, NOVEMBER 8, 1994**, between
20 the hours of six o'clock (6:00) a.m., and eight o'clock (8:00) p.m., in accordance with the
21 provisions of La. R.S. 18:541, and at the said election there shall be submitted to all
22 registered voters qualified and entitled to vote at the said election under the Constitution
23 and laws of this State and the Constitution of the United States, the following
24 propositions, to-wit:

12 GARBAGE TAX RENEWAL PROPOSITION

14 SUMMARY: AUTHORITY TO RENEW A TEN YEAR 5 MILLS PROPERTY TAX
15 FOR CONSTRUCTING AND MAINTAINING GARBAGE DISPOSAL WORKS AND
16 REFUSE AND GARBAGE COLLECTION AND DISPOSAL SYSTEMS WITHIN
17 AND FOR THE CITY.

19 Shall the City of Slidell, State of Louisiana, levy a five (5) mills tax on all property
20 subject to taxation in said City for a period of ten (10) years, beginning with the
21 year 1996 and ending with the year 2005, for the purpose of constructing and
22 maintaining garbage disposal works and refuse and garbage collection and
23 disposal systems within and for the City?

24
25 **SECTION 2. Publication of Notice of Election.** A Notice of Special Election
26 shall be published in "The Daily Sentry News," a daily newspaper of general circulation
27 within the City, published in Slidell, Louisiana, and being the official journal of the
28 Governing Authority, once a week for four consecutive weeks, with the first publication
29 to be made not less than forty-five (45) days nor more than ninety (90) days prior to the
30 date fixed for election, which Notice shall be substantially in the form attached hereto as
31 "Exhibit A" and incorporated herein by reference the same as if it were set forth herein
32 in full.

33 **SECTION 3. Canvass.** This Governing Authority, acting as the governing
34 authority of the City, shall meet at its regular meeting place, the City Hall, 2055 Second
35 Street, Slidell, Louisiana, on **TUESDAY, NOVEMBER 22, 1994, at SIX-THIRTY (6:30)**
36 **O'CLOCK P.M.**, and shall then and there in open and public session proceed to examine
37 and canvass the returns and declare the results of the said special Election.

38 **SECTION 4. Polling Places.** The polling places set forth in the aforesaid
39 Notice of Special Election are hereby designated as the polling places at which to hold
40 the said election, and the Commissioners-in-Charge and Commissioners, respectively, will
41 be the same persons as those designated in accordance with law.

6 SECTION 5. Election Commissioners; Voting Machines. The officers
7 designated to serve as Commissioners-in-Charge and Commissioners pursuant to Section
8 4 hereof, or such substitutes therefor as may be selected and designated in accordance
9 with La. R.S. 18:1287, shall hold the said special election as herein provided, and shall
10 make due returns of said election for the meeting of the Governing Authority to be held
11 on Tuesday, November 22, 1994, as provided in Section 3 hereof. All registered voters
12 in the City are entitled to vote at said special election and voting machines shall be used
13 thereat.


14 SECTION 6. Authorization of Officers. The Council Administrator/Clerk of
15 the Slidell City Council of the Governing Authority is hereby empowered, authorized and
16 directed to arrange for and to furnish to said election officers in ample time for the holding
17 of said election, the necessary equipment, forms and other paraphernalia essential to the
18 proper holding of said election and the Council Administrator/Clerk of the Slidell City
19 Council and/or President of the Council of the Governing Authority are further authorized,
20 empowered and directed to take any and all further action required by State and/or
21 Federal law to arrange for the election, including but not limited to, appropriate
22 submission to the Federal Department of Justice under Section 5 of the Federal Voting
23 Rights Act of 1965, as amended.

24 SECTION 7. Furnishing Election Call to Election Officials. Certified copies
25 of this resolution shall be forwarded to the Secretary of State, the Commissioner of
26 Elections, the Clerk of Court and Ex-Officio Parish Custodian of Voting Machines in and
27 for the Parish of St. Tammany, State of Louisiana, and the Registrar of Voters in and for
28 said Parish, as notification of the special election herein called in order that each may
29 prepare for said election and perform their respective functions as required by law.

30 SECTION 8. Application to State Bond Commission. Application is made
31 to the State Bond Commission for consent and authority to hold the aforesaid special
32 election as herein provided, and in the event said election carries for further consent

6 and authority to levy and collect the special tax provided for therein, and a certified copy
7 of this resolution shall be forwarded to the State Bond Commission on behalf of this
8 Governing Authority, together with a letter requesting the prompt consideration and
9 approval of this application.
