8 A resolution naming and appointing or reappointing Trustees of the St.
9 Tammany Public Trust Financing Authority and designating their terms of office.

10 WHEREAS, the St. Tammany Public Trust Financing Authority (the
11 "Authority") was created pursuant to an Indenture dated March 6, 1979, by the governing
12 authorities of the Cities of Covington and Slidell; and

13 WHEREAS, the terms of Trustees of the Authority have expired and there
14 is a need to name and appoint successor Trustees; and

15 WHEREAS, at the time of the creation of the Authority the governing
16 authorities of the Cities of Slidell and Covington established a practice of appointing as
17 trustees, the Mayor of Slidell, a Slidell Councilman-at-Large, the Mayor of Covington, the
18 Chairman of the Covington City Council and on alternate years, the Mayor of Mandeville
19 and the Mayor of Pearl River; and

20 WHEREAS, the governing authorities of Slidell and Mandeville subsequently
21 changed their policy to provide that the Mayors of Mandeville and Pearl River should
22 alternate on two year terms; and

23 WHEREAS, the Cities of Slidell and Covington have experienced changes
24 in some municipal offices; and

25 WHEREAS, the governing authorities of Slidell and Covington wish to clarify
26 the membership of the St. Tammany Public Trust Financing Authority in order to permit
27 the orderly transaction of business; and

28 WHEREAS the City Council of Slidell and Covington must ratify the
29 appointments.

30 NOW THEREFORE BE IT RESOLVED by the Slidell City Council, acting
31 as the governing authority of the City of Slidell, State of Louisiana:

32 SECTION 1. That there are hereby appointed or reappointed, as the case
33 may be, but in any case officially designated as trustees for members of the St. Tammany
34 Public Trust Financing Authority the following persons for the terms indicated:

6 Salvatore A. Caruso, Mayor of the City of Slidell, for a term expiring on
7 March 6, 1997, or until he should cease to hold his elected office of Mayor
8 of the City of Slidell;

10 Alvin D. Singletary, Councilman-at-Large of the City of Slidell, for a term
11 expiring on March 6, 1997, or until he shall cease to hold his elected office
12 of Councilman-at-Large of the City of Slidell;

14 Keith Villere, Mayor of the City of Covington, for a term expiring on March
15 6, 1997, or until he should cease to hold his elected office of Mayor of the
16 City of Covington;

18 Robert Champagne, Chairman of the Covington City Council, for a term
19 expiring on March 6, 1997, or until he shall cease to hold the office of
20 Chairman of the Covington City Council; and

21
22 James Lavigne, Mayor of the Town of Pearl River, for a term expiring on
23 March 6, 1996, or until he should cease to hold his elected office of Mayor
24 of the Town of Pearl River.

25 SECTION 2. That the above described appointments shall become effective
26 upon the concurrence of the City Council of the City of Covington.
