10 A resolution requesting the Environmental Protection Agency (EPA) and La.
11 DEQ to leave certain sheet pilings in place along Bayou Bonfouca.

12 WHEREAS, the EPA has a Superfund Clean-up Project underway in Slidell,
13 Louisiana; and

14 WHEREAS, as part of the operation, certain sheet pilings have been driven
15 to stabilize the banks along Bayou Bonfouca during the clean-up operation; and

16 WHEREAS, it is believed that said pilings would be an asset to the
17 landowners along said bayou; and


18 WHEREAS, it is feared that the removal of the pilings could cause damage
19 to certain property owners.

20 NOW THEREFORE BE IT RESOLVED that the Slidell City Council does
21 hereby request the Environmental Protection Agency (EPA) and La. DEQ to allow the
22 sheet pilings installed along the banks of Bayou Bonfouca as part of the Superfund
23 Project to remain in-place, and to further provide backfill to connect the sheet pilings with
24 the bank of the bayou on the following property:
