9 A resolution ordering a special election to be held in the City of Slidell, St.  
10 Tammany Parish, Louisiana, for the purpose of electing a new City Council Member from  
11 Councilmanic District F to fill the vacancy and unexpired term created by the resignation  
12 of Council Member J. T. "Tom" Schedler.

14 WHEREAS, the City of Slidell by resolution passed this day has declared  
15 a vacancy to exist in the Slidell City Council from Councilmanic District F, City of Slidell,  
16 St. Tammany Parish, Louisiana; and

17 WHEREAS, the governing authority for the City of Slidell is given the  
18 authority and responsibility under the provisions of Louisiana Revised Statutes 18:602 and  
19 Slidell Home Rule Charter Section 2-03, Paragraph C, to fill the vacancy and the position  
20 of City Council Member by special election when an unexpired term exceeds one (1)  
21 year; and

22 WHEREAS, the vacancy declared this day by the Slidell City Council results  
23 in the creation of an unexpired term in excess of one (1) year.


24 NOW THEREFORE BE IT RESOLVED by the Slidell City Council that it  
25 does hereby authorize and call a special election to be held in the City of Slidell, St.  
26 Tammany Parish, Louisiana, for the purpose of electing a City Council Member to fill the  
27 vacancy declared this day by the Slidell City Council for Councilmanic District F for the  
28 unexpired term of Council Member J. T. "Tom" Schedler.


29 BE IT FURTHER RESOLVED that the filing dates for qualification for said  
30 election shall be from January 10 through January 12, 1996, inclusive, and that the  
31 primary election shall be held on March 12, 1996, with a general election, if necessary,  
32 held on April 20, 1996, and that said election shall be conducted in accordance with the  
33 election laws of the State of Louisiana.

34 BE IT FURTHER RESOLVED that the Council Administrator/Clerk of the  
35 Council of the City of Slidell, St. Tammany Parish, Louisiana, shall send a copy of this  
36 resolution to the Louisiana Secretary of State, State of Louisiana, and shall further cause  
37 this resolution to be published in the Official Journal as required by law.

5 BE IT FURTHER RESOLVED that the results of the election shall be  
6 promulgated as required by law.
