9 A resolution indicating the intention of the City of Slidell, State of Louisiana,
10 to become a participating political subdivision in the Louisiana Local Government
11 Environmental Facilities and Community Development Authority (the "Authority");
12 approving the appointment of a Director to represent the City of Slidell on the Board of
13 Directors of the Authority; and otherwise providing with respect thereto as provided by
14 Chapter 10-D of Title 33 of the Louisiana Revised Statutes of 1950, as amended.

16 WHEREAS, Chapter 10-D of Title 33 of the Louisiana Revised Statutes of
17 1950, as amended, comprised of R.S. 33:4548.1 through 4548.16 is known as the
18 Louisiana Local Governmental Environmental Facilities and Community Development
19 Authority Act (the "Act"); and

20 WHEREAS, the Act creates the Louisiana Local Government Environmental
21 Facilities and Community Development Authority (the "Authority") for the purpose of
22 assisting political subdivisions, as defined in the Act, and other designated entities in
23 acquiring, financing and constructing certain facilities, including environmental, public
24 infrastructure, community and economic development purposes and to otherwise establish
25 programs to aid in the financing of local government and economic development projects;
26 and

27 WHEREAS, the City of Slidell, State of Louisiana, is eligible to become a
28 participating political subdivision of the Authority in accordance with the Act; and

29 WHEREAS, pursuant to Section 4548.4 of the Act, the governing authority
30 of the City of Slidell, State of Louisiana, desires to become a member of the Authority and
31 to approve the appointment of Reinhard Dearing, Chief of Staff of the City of Slidell, to
32 serve as a Director of the Authority.

33 NOW THEREFORE BE IT RESOLVED by the Slidell City Council that:

34 Section 1. Under the authority of Section 4548.4 of the Act, it is hereby
35 declared to be the express intention of the City of Slidell, State of Louisiana, to become
36 a participating political subdivision and member of the Authority.


