8 A resolution asking the Municipal Code Corporation to make adjustments to  
9 the Code of Ordinances of the City of Slidell, Louisiana to provide for correct capitalization  
10 in Sections 2-31, 2-32, 2-33, and 2-34.

12 WHEREAS, certain errors of capitalization as to Sections 2-31, 2-32, 2-33,  
13 and 2-34 of the Code of Ordinances of the City of Slidell, Louisiana have apparently been  
14 made by the printing company in the codification process; and

15 WHEREAS, Ordinance No. 794 that adopted these sections into law contains  
16 the correct capitalization; and

17 WHEREAS, it is proper for the sections printed in the Code of Ordinances of  
18 the City of Slidell, Louisiana to be printed with the correct capitalization as shown in  
19 Ordinance No. 794.

20 NOW THEREFORE BE IT RESOLVED by the Slidell City Council that "board  
21 of trustees of the municipal employees retirement system" shall be corrected to "Board of  
22 Trustees of the Municipal Employees Retirement System" in Section 2-31 of the Code of  
23 Ordinances of the City of Slidell, Louisiana.

24 BE IT FURTHER RESOLVED that "board of trustees in accordance with Act  
25 No. 356 of 1954, and shall be paid over to the board of trustees" shall be corrected to  
26 "Board of Trustees in accordance with Act No. 356 of 1954, and shall be paid over to the  
27 Board of Trustees" in Section 2-32 of the Code of Ordinances of the City of Slidell,  
28 Louisiana.

29 BE IT FURTHER RESOLVED that "board of trustees in accordance with  
30 applicable state laws and regulations of said board of trustees" shall be corrected to "Board  
31 of Trustees in accordance with applicable state laws and regulations of said Board of  
32 Trustees" in Section 2-33 of the Code of Ordinances of the City of Slidell, Louisiana.


33 BE IT FURTHER RESOLVED that "board of trustees" shall be corrected to
